## ***Data Protection Policy***

This Antimicrobial Auditing Tool enables the collection of data regarding antimicrobial use from veterinary consultations and owner reported outcomes pre and post consultation.

Any personal data collected within the process is subject to the General Data Protection Regulations and Data Protection Act (2018), and as such are collected under the following principles:

Each individual user and RCVS Knowledge are joint data controllers, therefore both are subject to the controller requirements set out under the General Data Protection Regulations. The data processor is Amplitude Clinical Outcomes.
