Role summary

Role description

- To ensure that RCVS Knowledge complies with its Memorandum and Articles of Association, charity law, company law and any other relevant legislation or regulations.
- To ensure that RCVS Knowledge pursues its Objects as defined in its Memorandum and Articles of Association.
- To ensure that RCVS Knowledge uses its resources exclusively in pursuance of its Objects: RCVS Knowledge must not spend money on activities which are not included in its own Objects, no matter how worthwhile or charitable those activities are.
- To contribute actively to the Board of Trustees' role in giving firm strategic direction to RCVS Knowledge, setting overall policy, defining goals and setting targets and evaluating performance against agreed targets.
- To safeguard the good name and values of RCVS Knowledge.
- To ensure the effective and efficient organisational administration of RCVS Knowledge.
- To ensure the financial stability of RCVS Knowledge.
- To protect and manage the property of RCVS Knowledge and to ensure the proper investment of RCVS Knowledge's funds.
- To appoint the Director and monitor his/her performance.

Other duties

- To act as an ambassador of the charity promoting its good name and work as well as that of its other Trustees, volunteers, and staff.
- To scrutinise the Board papers thoroughly and other relevant documents including governance guidance.
- To attend all Board meetings as well as other important events where possible.
- To employ their individual skills, knowledge, or experience to help the Board reach sound decisions.
- To take the lead on discussions and activities where RCVS Knowledge has specific and relevant experience.
